- 2960 Strasburg Road renovation of the historic resource and former one-room schoolhouse

 danger of demolition by neglect as it has been left unprotected from the effects of weather and
 intrusion by vermin or unauthorized entry by trespassers.

- People's Hall a Class I historic resource which is included in the Ercildoun Thematic District (National Register of Historic Places), built in 1845 by the abolitionist group, East Fallowfield Anti-Slavery Society to hold their meetings, subsequently being home to various groups and meetings in the Township.

- The new Board of Trustees has been unable to solicit sufficient funds to make the needed repairs to the building. The Board is contemplating a number of ideas as to how to move forward with the building.
