A RESOLUTION OF ADOPTION FOR AN ACT 537 OFFICIAL SEWAGE FACILITIES PLAN FOR EAST FALLOWFIELD TOWNSHIP

Resolution of the Board of Supervisors for East Fallowfield Township, Chester County, Pennsylvania (herein "the municipality").

WHEREAS, Section 5 of the Act of January 24, 1966, P.L. 1535, No. 537 known as the "Pennsylvania Sewage Facilities Act", as amended, and the Rules and Regulations of the Pennsylvania Department of Environmental Protection ("the Department") adopted thereunder, Chapter 71 of Title 25 of the Pennsylvania Code, required municipalities to adopt an Official Sewage Facilities Plan providing for sewage facilities adequate to prevent contamination of waters and/or environmental health hazards with sewage wastes, and to revise said plan whenever it is necessary to meet the sewage disposal needs of the municipality, and

WHEREAS, AECOM has prepared an Official Sewage Facilities Plan ("the Plan") which provides for acquisition of the Valley Township's sewage facilities by Pennsylvania- American Water Company, and

WHEREAS, portions of East Fallowfield Township are served by the Valley Township's sewage facilities, and

WHEREAS, the selected alternative of the Plan is the acquisition of Valley Township's sewerage system by Pennsylvania-American Water Company, with Pennsylvania-American Water Company becoming the owner and operator of all sewerage system assets as described in the Plan.

NOW, THEREFORE, BE IT RESOLVED that East Fallowfield Township has found the Plan adequate for the wastewater disposal and management needs of the municipality and hereby adopts the Plan known as the Official Sewage Facilities Plan: Acquisition of Valley Township's Sewage Facilities by Pennsylvania-American Water Company, dated August 2021, as a revision to the Official Plan of the municipality. The East Fallowfield Township Board of Supervisors hereby assures the Department of the proper and timely implementation of said Plan as set forth herein.
