2030	08/02/08 1134/1221	Gum Tree Road North of Topper Lane Highland Township	SUSPCON: EF Ofc. was requested to assist Coatesville PD with the investigation of a suspicious conditions that was occurring in Highland Township. A citizen reported that earlier today a large drill worth \$10,000 had been reported stolen from a Verizon sub station in the City. A citizen witnessed the incident and followed the vehicle to this location, a scrap yard. Parkesburg PD was not on duty in Highland and no troopers were available. Coatesville PD also had no officers immediately available. Ofc. did respond and locate the vehicle. The citizen identified the stolen drill and took possession of the item at the scene. Ofc. took one subject into custody for a bench warrant. Coatesville PD later responded and transported all subjects back to their station. TOT CPD.

After a 10 hour search Ofc. Harper located the missing person. He was found deceased in his vehicle parked at the rear of a construction site in West Bradford Township. State Police were notified and responded along with Coroner. Ofc. made notification to family and stood by while troopers interviewed the wife.

Suspects were reported to be dealing drugs and armed with firearms. The detail was cancelled for investigative reasons and no service was necessary.

Investigation is ongoing and CCD Computer Crimes unit is assisting. She later called the chief and advised the suspect had also called her multiple times at her recently changed home telephone number. On 08/26/08 the victim called the Chief and stated that she located a possible electronic tracking device in the trunk of her vehicle. The device was recovered and placed it into evidence for further investigation. This is related to an ongoing stalking case. Investigation is ongoing. To date there has been three court orders issued for the disclosure of cellular, ISP and electronic records and a search warrant executed for the suspect's computers.

Upon ofc's arrival it was learned that one male caught the other allegedly in a relationship with his wife. The husband rammed the victim's vehicle while it was occupied by the suspect's wife and three kids, disabling it and then confronted the victims. The suspect was detained and later charged with several counts of aggravated assault. He was also charged by Coatesville PD for an assault that occurred in the City.
