ORDINANCE NO. 2003 - 04

AN ORDINANCE PURSUANT TO SECTION 2328 OF THE SECOND  
CLASS TOWNSHIP CODE, AS AMENDED, PROVIDING FOR THE  
REGULATION OF PARKING WITHIN EAST FALLOWFIELD  
TOWNSHIP. EFFECTIVE FIVE DAYS FROM ENACTMENT.

AND NOW, this 23 day of October, 2003, the Board of Supervisors of East Fallowfield Township hereby enacts and ordains as follows:

**Section 1.** Title. This ordinance shall be cited to as the "East Fallowfield Township Parking Ordinance".

**Section 2.** Definitions. Words and phrases, when used in this ordinance, shall have meanings ascribed to them in the Vehicle Code of the Commonwealth of Pennsylvania (75 Pa.C.S.A. §101 et seq.) (hereinafter "Vehicle Code"), as now in force, or as hereinafter amended, enacted or reenacted, except where the context clearly indicates a different meaning.

**Section 3.** Parking. No person shall park a motor vehicle at any time upon any street or road of the township or upon any of the highways or parts thereof described below:

**Section 4.**     **Erection of signs.** The Roadmaster of East Fallowfield Township, with reference to roads under township jurisdiction, is hereby authorized to erect appropriate signs to designate parking regulations. The placement of the signs regulating motor vehicles under this ordinance shall be in accordance with and subject to the provisions of the Vehicle Code.

**Section 5.**     **Parking violations and penalties; enforcement.**

A. Any person, firm or corporation violating any of the provisions regulating parking or any of the regulatory parking signs (including appropriate markings on the pavement) shall, for each and every such violation of said parking regulation (or parking control sign or marking) taking

place within East Fallowfield Township and upon ticketing of each vehicle in violation owned or operated by said person, firm or corporation, be ordered to pay a fine of \$15 payable to East Fallowfield Township within 14 days of issuance of such notice for each of the following parking violations:

- (1) Parked in a posted no-parking zone.
- (2) Parked in a posted temporary no-parking zone.
- (3) Parked within 15 feet of a fire hydrant.
- (4) Parked within 30 feet of a stop sign.
- (5) Double-parked.
- (6) Parked in a handicapped space.
- (7) Parked in a fire zone.
- (8) Parked against traffic flow.
- (9) Parked within 20 feet of a crosswalk.
- (10) Parked on a sidewalk.
- (11) Parked in front of a private or public drive.
- (12) Parked within an intersection.

B. Failure to respond to the notice of violation by payment of the fine, as aforesaid, which payment must be made to East Fallowfield Township within 14 days of issuance of such notice, shall result in the issuance of a citation to the defendant. Thereafter, the prosecution shall proceed in the same manner provided for enforcement of summary offenses under with the Pennsylvania Rules of Criminal Procedure; and upon conviction of the offense, the defendant shall be ordered to pay a fine of \$15, together with the costs of prosecution.

C. It shall be the duty of the enforcement officers of East Fallowfield Township to report all violations of any provision of this ordinance, indicating in each case the section thereof violated, the license number of the vehicle involved in such violation, the location where the violation took place, the time of such violation and any other facts necessary to secure a clear understanding of the circumstances attending such violation. Each such officer shall also place on such vehicle a notice of violation to the owner or operator thereof that such vehicle has been parked in violation of the provisions of this chapter, instructing such owner or operator to pay the fine and costs as provided herein and further notifying such owner or operator that failure to respond will result in the issuance of a citation.

**Section 6.**     **Severability.** If any provision, paragraph, word, section or article of this ordinance is invalidated by any court of competent jurisdiction, the remaining provisions, paragraphs, words, sections and chapters shall not be affected and shall continue in full force and effect.

**Section 7.**     **Repealer.** All other ordinances and parts of other ordinances inconsistent or conflicting with any part of this ordinance are hereby repealed to the extent of such inconsistency or conflict.

**Section 8.**     **Effective date.** This ordinance shall be effective five (5) days from the date of enactment.
